

# European School of Oncology APPLICATION FOR THE "ESO RECOMMENDED EVENT" LABEL

#### Introduction and criteria

The organisers of an educational event may submit a request to obtain the "ESO Recommended Event" label if the following criteria are met:

- The event is of relevance to the oncology community and meets an educational need;
- Attracts an international audience;
- Is held in a geographical area that is related to ESO's educational activities;
- The programme is independent and unbiased;
- The event is not mono-sponsored and is not a commercially focused event;
- ACOE accredited or the application for CME accreditation is planned.

This patronage initiative requires a no-cost reciprocal exchange of promotional opportunities.

## Benefits for the applicant

In addition to the patronage, the label allows ESO's support in terms of promotion via the following:

- The event details (title, dates, location and website) will be listed in the relative section on the ESO website <a href="www.eso.net">www.eso.net</a> (a logo or an image of the event needs to be provided);
- A banner of the event will be included in one of ESO's e-newsletters (including e-ESO and ESCO), if space is available. If you would like to consider this option, please provide us with a .jpeg image (format 1800x330 pixels) at least two months before the date of the event;
- ESO agrees to repost social media promotion you may do for the event via its social media platforms (Twitter/Facebook/Instagram). It is necessary that you tag @ESOncology in order for us to do this;
- ESO will include a slide of the event in the power point carrousel presented to the audience before relevant e-ESO sessions on similar topics, if available. *The slide must be sent to us in due time*.

## Responsibilities of the applicant

If your request is successful, the "ESO Recommended logo" must be published in all electronic and printed announcements and any other communications relating to the event. When the communication is electronic, please link the logo to <a href="https://www.eso.net">www.eso.net</a>.

The logo must not be placed side by side with or within spaces dedicated to pharmaceutical companies. The logo may be placed side by side or stand in areas dedicated to other non-profit organisations or societies. ESO must not appear in any lists together with pharmaceutical companies. In any case, online or offline graphic material involving Eso or Eso Recommended logos must be shared with the ESO Communication Team for final review and approval.
